## **PUBLIC COMMENTS**

Approximately 25 Classified Workers stood behind the podium to show their support for their 7 colleagues who addressed the Trustees regarding a wage increase for members of this bargaining unit. Speakers included Jeanie Brown, Chief Negotiator for the SCCCE, Barbara Poynter, SCCCE Negotiating Team Member, and Food Service Worker Michael Rodriguez. Speakers asked the Trustees to direct Administrators to provide classified workers with a 3% increase on the salary schedule for 2014-15. Classified workers provide direct support for students in many capacities; including classroom aide, yard duty, clerical services, community coordinators,

food service workers, custodians, bus drivers and more. Dr. Jim Logsdon reported that community member George Ow is pleased to support upcoming parcel tax measures O & P and gives permission to use his name as a supporter during the campaign.

# **Superintendent's Report**

Superintendent Munro, Ms. Parks and Mr. Monreal attended a valuable legal training in Campbell on September 29. The Soquel High School homecoming event was successful and well-attended, and the football game was played on newly installed turf. The Superintendent was welcomed as a member of the Santa Cruz Rotary last week, and on October 6<sup>th</sup>, Ms. Munro and Ms. Meeker will be presenting an update about Santa Cruz City Schools at the Sunshine Rotary Club, where Ms. Meeker is applying for membership. The District Marketing Committee met yesterday for the first time this school year to discuss work in progress and plans for the coming school year. Superintendent Munro is pleased to report that Santa Cruz City Schools has been involved in the Panama Project (Partners in Research and Education through the University of Florida) for four years. Last week, Erin Petersen-Lindberg's 6<sup>th</sup> grade class had a google chat with Dr. Johnathan Hendricks, a geologist and paleontologist that participated in the Panama trip this past summer. The students worked hard to create scientific questions to ask him about his work, and Ms. Munro was told that the questions were of the caliber used to guide scientific research. The Small Schools campus will be celebrating the 100 year birthday of the Branciforte Elementary Building on Tuesday, October 13, from 12:00 – 2:00 p.m.

### **Student Representatives' Reports**

Student Pageler reported that the Harbor High School Back To School Night was held on the same night as the DeLaveaga Elementary Back To School Night, and families were forced to split up to cover both events. Student Pageler was fortunate to give a presentation in one of the classrooms. The "Club Rush" was held on Friday, September 25<sup>th</sup>. Fall Sports are in full swing and the Boys' Water Polo team had their first win in 20 games. The Fall play, "You Can't Take It With You" begins in two weeks.

Student Carroll reported that the Santa Cruz High School Back To School Night was a success. "Club Days" included some new clubs, reestablishment of some former clubs and fundraising for clubs. This week Santa Cruz High School students are celebrating "banned books" week and starting sign-ups for an upcoming blood drive. A new digital photography class is available and the Fall play, "You Can't Take It With You" begins in two weeks.

#### **BOARD MEMBERS' REPORTS**

#### **Board Members' Reports**

Board Member Tracy-Proulx reported a great start to the school year for her family. The Branciforte Middle School Tamalada was great fun!

Board Member Perez-Granados attended the Back To School Night at Harbor High School and had a great time. The teachers seemed very excited to part of the Harbor High School team.

Board Member Shonick spoke about District Goal #4: We will develop a highly collaborative, professional culture focused on supporting effective teaching. Mr. Shonick reported he is eager to hear the report later this evening from our SCCS secondary teachers who participated in summer learning opportunities. This type of direct communication from teachers to the school board is vital if the board is to give proper direction and be kept up to date regarding Goal #4. Mr. Shonick would also like to hear from the Teachers on Special Assignment in the near future. A highly collaborative, professional culture focused on supporting effective

teaching cannot emerge without the direct leadership of teachers themselves. Trustee Shonick commends Ms. Meeker and the rest of her staff for their hard work on this much needed process.

Board Member Threet welcomed the Student Representatives to the Board of Education. Ms. Threet attended the Back To School Night and worked the Barbeque fundraiser for Soquel High School. Trustee Threet attended the Safety Meeting at Santa Cruz High School and the Homecoming festivities for Soquel High School. Board Member Threet invited everyone to help in campus beautification at Santa Cruz High School on the fourth Sunday of each month and commends the families who take part for their hard work on behalf of our students.

Board Member Thompson attended the Parcel Tax Oversight Committee meeting on September 14 and volunteered at the Harbor High School Green and Gold Barbeque, where over 300 meals were served. Dr. Thompson is very impressed with the wide range of clubs and activities that are offered at Harbor High School through the Club Rush – it is a wonderful tradition and a great way to welcome 9<sup>th</sup> grade students to a new school. Dr. Thompson also had fun at the Branciforte Middle School Tamalada on September 25.

Board Member Coonerty has been away and is pleased to be back in Santa Cruz and in attendance for the meeting of the Board of Education. Dr. Coonerty attended the Safety Meeting at Santa Cruz High School and worked at the phone bank for Parcel Tax Measures O & P. The phone bank was a very nice experience – folks are very positive about Santa Cruz City Schools and are quick to say they will support these measures. Dr. Coonerty attended the 50<sup>th</sup> reunion of the pioneer class at UCSC, and was reminded of the wonderful emotional connections between teachers and students at Santa Cruz City Schools. Teachers here encourage students to have new ideas and try new things and Dr. Coonerty is very proud of our teachers and support staff.

# **Board President's Report**

Board President Vestal attended the Delta Back To School Night and the Delta School Board meeting and budget study session. # 8.3.1 Staff Report: Illuminate Professional Development

Ms. Meeker introduced Curriculum Director Wildman to report to the Board of Education. Information presented included: current training sessions/users; district funding for this program; direct support from Curriculum and Information Technology for implementation; direct support for end-users from vendor; implementation goals; implementation challenges. The Board asked questions and offered comments. This report was informational in nature, and no action was taken by the Board of Education regarding this matter.

#### 8.3.2 Staff Report: Summer Professional Learning

Ms. Meeker reported that over the summer break, SCCS offered two summer learning opportunities that reflect ongoing work to support students' academic success and social emotional health. In Spring 2015, secondary Science teachers participated in training on Next Generation Science Standards. Over the summer break, teachers met again to develop instructional units based on their professional learning. Teachers will continue to meet with each other and the SCCS Science Teacher on Special Assignment during the school year regarding unit design and implementation. Presenters included: Heather Murphy, Mike Lynch, Laura Beach, Gail Alaimo and Janna Bedell. After the conclusion of this part of the presentation, the Trustees asked questions and offered comments.

SCCS Student Services Director Eileen Brown reported on the Trauma Informed Schools. In August, more than 90 staff members, including teachers, counselors, psychologists and administrators participated in a training provided by the California Center for Excellence in Trauma Informed Care. The goals of this training were to: increase knowledge regarding the impact of adverse childhood experiences on behavior and learning; implement student strategies designed to increase student safety and academic achievement; improve students' self-regulation skills; improve classroom

perseverance skills. Staff at Branciforte Middle School and the Small Schools campus will continue to participate in trainings throughout the 2015-16 school year.

This report was informational in nature, and no actions regarding these matters were taken by the Board of Education.

Mr. Monreal reported federal laws and regulations permit a public agency to issue bonds and use the proceeds to reimburse the District's General Fund or other funds for expenses incurred in advance of the issuance of tax exempt obligations, as long as the District takes an official action to evidence its intent. Mr. Shonick moved approval of Resolution 12-15-16 ESD and Resolution 13-15-16 HSD to Reimburse Tax Exempt Expenditures and Dr. Thompson seconded this motion. The motion was passed by roll call vote, as follows:

Mr. Monreal reported that these resolutions are required to bring the district into compliance with Internal Revenue Code regarding Section 125 Flexible Fringe Benefits plans offered to district employees. Dr. Coonerty moved approval of Resolution 14-15-16 (Management), Resolution 15-15-16 (Certificated), and Resolution 16-15-16 (Classified) Section 125 Renewals and Dr. Thompson seconded the motion. The motion was approved by roll call vote, as follows:

## 8.3.5 New Business: Approve Agreement between SCCS and GSCFT

Ms. Parks reported that our District Nurses have much work to be done prior to the first student day of each school year. The new agreement extends their annual work schedule by 16 days to allow time for this important work and places these employees on the same salary schedule as the School Psychologists and Speech Language Pathologists. MSP (Coonerty/Tracy-Proulx) 7-0, the Board of Education approved the agreement between SCCS and the GSCFT regarding District Nurses.

#### 8.3.6 New Business: Revised Salary Schedules: District Nurses

MSP (Threet/Tracy-Proulx) 7-0, the Board of Education approved the revised salary schedules for District Nurses as called for by the agreement approved in the previous board agenda item.

#### 8.3.7 New Business: Revision of District Goal #2

Superintendent Munro reported that, in August, the Trustees requested a revision to District Goal #2. The Superintendent has crafted a revised goal for approval by the Board of Education. The proposed goal reads: SCCS will create positive, engaging school environments that promote the development of cognitive skills and the social emotional well-being of all students. MSP (Thompson/Perez-Granados) 7-0, the Board of Education approved revised District Goal #2.

#### 8.3.8 New Business: Approve Sunshine Items between SCCS and SCCCE

Ms. Parks reported that while these two items, Wages and Benefits, are open for discussion each year during negotiations, her intent is to provide full disclosure. MSP (Coonerty/Thompson) 7-0, the Board of Education approved the sunshine items between SCCS and SCCCE.

# **8.3.9** New Business: PUBLIC HEARING: Textbook Sufficiency for the Elementary and High School Districts Open: Board President Vestal opened this Public Hearing at 8:57 p.m.

Ms. Meeker reported that, in order to be eligible to receive instructional materials funds, Education Code 60119(a)(1) requires the governing board of each LEA to hold an annual public hearing. The purpose of the hearing is to make a determination, through a resolution, as to whether each child in the district has, or will have prior to the end of the fiscal year, sufficient textbooks or instructional materials in specific subjects aligned with academic content standards. This public hearing fulfills the compliance requirement for 2015-16.
