Welcome and Format

Board President Tracy-Proulx welcomed those in attendance and explained the format used for this Regular Meeting of the Board of Education.

Agenda Changes

Board Recording Secretary Lentz asked to pull Item 7.1. Minutes of the Meeting on May 10, 2017 from the agenda. The minutes were not included in the published board book and cannot be voted on this evening. These minutes will come back to the Board on May 31st for approval. Board Recording Secretary Lentz asked to pull Item 8.2.2.4. Expulsion 26-16-17 from the agenda, as the item is not moving forward at this time and cannot be voted on this evening.

PUBLIC COMMENTS

Drew Glover, Executive Director of Project Pollinate in Santa Cruz County, read a letter on behalf of the organization urging the Board of Education to use less chemicals on school grounds to manage rodents and insects. Alternative Family Education students Max Freedman and Jackson Damhorst reported on their experiences with their science project, *Effects of Varroa Mite Treatments on Bee Memory*. This student project won overall Best Overall Project at the Santa Cruz County Science Fair, 1st place at the California State Science Fair and 4th place in animal sciences at the Intel International Science and Engineering Fair in Los

Angeles on May 19. The students encouraged the Trustees and District Administrators to include more project based learning in the curriculum.

SUPERINTENDENT'S REPORT

Superintendent's Report

Superintendent Munro welcomed and introduced the new Santa Cruz City Schools Finance Director Greg Torr. The Superintendent extended her gratitude to everyone who worked to make the Guelaguetza on May 21 possible; especially Fe Silva, Nereida Robles, Curt Coleman, Carolyn Coleman and the Senderos Board, and the more than 100 volunteers from SCCS - teachers, classified staff members and administrators and UCSC students. Superintendent Munro thanked local elected and non-profit leaders who attended and supported the event – Supervisors Coonerty and Leopold, Mayor Cynthia Chase, City Manager Martin Bernal and Community Foundation Program Director Christina Cuevas. It was an incredible day celebrating our students and families and their rich indigenous cultures. On May 19, Finance Director Greg Torr, SCCCE President Robert Chacanaca and GSCFT Bargaining Team Member Mark McConnell attended the May Revise Workshop hosted by School Services of California. We appreciate the on-going collaboration with the bargaining units and more information on the revise will be provided later in the meeting tonight. On May 22, Superintendent Munro participated in panel interviews for the new Police Chief for the City of Santa Cruz and appreciated being included on the community panel. The process was thorough and thoughtful. The Superintendent invited all Trustees to attend the Retirement Celebration on May 25 at 5:00 p.m. at the Food Lounge in Santa Cruz. The Superintendent thanked the Human Resources team for their work to prepare for this important event.

Dr. Thompson attended the 20th Annual Queer Youth Leadership Awards Dinner in Watsonville on May 13, and recognized both SCCS Student Services Director Brown and the excellent article in the Santa Cruz Sentinel about the progress of our local school districts in supporting this student population.

Board Member Perez-Granados attended the Guelaguetza and is grateful for an event that is focused on sharing the rich cultures in our Santa Cruz City Schools. Dr. Perez-Granados attended the Budget Advisory Committee meeting yesterday.

Board Member Threet continues to meet with community members who have ideas on how to proceed with bond projects, and Ms. Threet appreciates district administrators for their excellence at both running the district and also finding the time to reach out to the community. Board Member Threet attended the County Office of Education May Revise information meeting. Trustee Threet appreciates the inclusion of an upcoming agenda item regarding the use of pesticides and herbicides at Santa Cruz City Schools campuses. ITEMS of BUSINESS to be TRANSACTED and/or DISCUSSED

8.3.1. New Business: Bond Update-Amendment: Soquel High School Pool Design

Mr. Gaffney reported to the Board of Education. While the district had originally recommended a 35 meter pool, following the community meetings last week, Mr. Gaffney shared that the Soquel community desires a 40 meter pool. This morning, Mr. Gaffney had a conversation with Mr. Isaac, a consultant who has worked with districts in 26 states on pool project designs. Mr. Isaac will assess both needs and opportunities for the district in a short amount of time and provide information from a neutral third party to inform a final decision on the size of the pool. As a result of utilizing these services, the amendment tonight lacks the specific dimensions of the Soquel High School Pool project. After receiving a final recommendation from Mr. Isaac, this item will return on June 28 with pool dimensions included. Board comments and questions followed Mr. Gaffney's report. Board President Tracy-Proulx also thanked Mr. Miller for his time and interest in this matter.

Public Comments:

Soquel High School head Swim Coach Winter thanked the Trustees and the District Administrators for the extra time to assess this project. The path proposed by Mr. Gaffney seems beneficial to everyone, and Coach Winter encouraged the use of the pool design consultant. A second speaker thanked the Trustees and District Administrators for taking the opportunity to connect with the community regarding this matter.

MSP (Threet/Coonerty) 7-0, the Board of Education approved Amendment #3 for the Soquel High School Pool Project.

8.3.2. <u>Staff Report: Response to Intervention (RtI) Social Emotional</u>

Mr. Wells introduced Student Service Director Brown to report to the Board of Education. Ms. Brown reported that the coordination of student services for Foster youth, homeless students, and other students creates a supportive atmosphere in which students feel safe, important, known and valued. If

school climate is improved for all, students will attend school and have fewer behavior concerns. If intensive supports are provided to students in need, they will attend school and will be ready to learn. Other topics included: Local Control Accountability Plan (LCAP) funded programs and positions; Primary Intervention Program (PIP); Social Work services and data collection; Positive Behavior Interventions and Supports (PBIS); Tiered Fidelity Inventory (TFI) - a reliable and efficient measure of the extent to which school employees are applying the core features of school-wide positive behavior interventions and supports; discipline data from this school year; areas for improvement. Board comments and questions followed the report. This report was informational in nature, and no actions were taken by the Board of Education regarding this matter.

8.3.3. Staff Report: May Revise

Superintendent Munro welcomed Finance Director Torr to report to the Board of Education. Mr. Torr reported to the Board of Education regarding this matter. Information included: how the Governor is preparing for slower economic growth; changes in personal income, sales and corporation tax revenue in the coming year; the January Budget vs. the May Revision; 2017-18 Local Control Funding Formula (LCFF) target funding factors; one-time discretionary funds; school facility program: grant agreement and project audit; available unrestricted revenue. Board comments and questions followed the report.

Public Comment: GSCFT President Kirschen requested that the new budget information be presented in a similar format as the previous budget information for comparison purposes.

This report was informational in nature, and no actions were taken by the Board of Education regarding this matter.

8.3.4. New Business: Declaration of Need Certificated 2017-18

Ms. Parks reported that beginning July 1, 1994, any public school district wishing to employ individuals on emergency permits or limited assignment permits must file a Declaration of Need with the California Commission on Teacher Credentialing (CCTC) on an annual basis. This Declaration allows for credentialing flexibility for both elementary and secondary schools. The estimated numbers needed listed here are not necessarily a determinant of current need but an educated guess to cover all areas of potential need. Ms. Parks recommended approval of both the elementary and secondary Declaration of Need Certificated 2017-18. MSP (Thompson/Perez-Granados) 7-0, the Board of Education approved the elementary and the secondary Declaration of Need Certificated 2017-18.

9. Adjournment of Meeting

As there was no further business for the Open Session Meeting, Board President Tracy-Proulx adjourned this meeting at 9:06 p.m.
