3.1.1. Information Item: Santa Cruz City Schools Partnership with the City of Santa Cruz re: Natural Bridges

Mr. Gaffney reported that the City of Santa Cruz is interested in expanding its partnership with Santa Cruz City Schools at the Natural Bridges Site. The District has multiple long term partnership agreements with the City for shared facility use, including an agreement and partnership on the Natural Bridges site that was established on April 15, 1989. Currently, Santa Cruz City Parks and Recreation offers many programs in the gym on the Natural Bridges campus. The City would like to pursue a matching funds grant that could award a maximum of \$1,000,000 to support replacing the field space on the campus with artificial turf and help meet the demand for space by youth sports programs serving our students and families. The application deadline is November 1, 2016.
